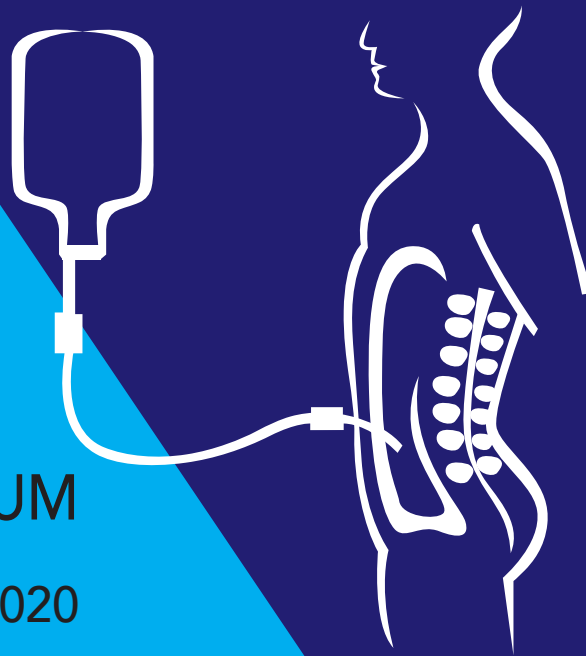

This is a one day zoom conference on peritoneal dialysis sponsored by the Icahn School of Medicine at Mount Sinai. Practitioners, researchers, and registered nurses who are expert in the field of kidney diseases will discuss current developments in the area of Peritoneal dialysis and related dialysis modalities. The topics will range from basic understanding of peritoneal dialysis prescription to rationale management of its complications. Particular attention is being given to the potential and actual use of peritoneal dialysis during this COVID-19 area. In addition to the professional experts, patients will also be participating in this conference to give their perspective of how chronic peritoneal dialysis has been the right choice for them.

The conference is designed for health professionals involved in established PD programs as well as those working in new and developing programs. Both researchers and clinicians will find sessions of interest to them.
